**A RESOLUTION****TO CREATE THE TEMPORARY STUDENT GOVERNMENT FINANCIAL RESTRUCTURE COMMITTEE**

**PARAGRAPH 1:** WHEREAS, THIS COMMITTEE WOULD MEET TO DISCUSS THE RESTRUCTURE OF STUDENT GOVERNMENT FINANCES AND ACCOUNTS; AND

**PARAGRAPH 2:** WHEREAS, THIS COMMITTEE WOULD BE MADE UP OF:

- THE STUDENT BODY PRESIDENT OR HIS OR HER DESIGNEE;
- THE SPEAKER OF THE SENATE OR HIS OR HER DESIGNEE;
- THE CHAIR
- VICE CHAIR OF THE COMMITTEE ON BUDGET AND APPROPRIATIONS, OR HIS OR HER DESIGNEE;
- THE DIRECTOR OF FINANCE
- ASSISTANT DIRECTOR OF FINANCE OR HIS OR HER DESIGNEE;
- THE STUDENT GOVERNMENT FINANCIAL COORDINATOR;
- ONE (1) MEMBER OF FINANCE AND ADMINISTRATIVE SERVICES

**PARAGRAPH 3:** WHEREAS, THE FIRST ORDER OF BUSINESS OF THIS COMMITTEE SHALL BE TO ELECT THE CHAIR OF THE COMMITTEE; AND

**PARAGRAPH 4:** WHEREAS, THE FINDINGS AND FINAL VOTES OF THIS COMMITTEE SHALL BE PRESENTED TO THE STUDENT SENATE IN THE FORM OF LEGISLATION.

**PARAGRAPH 5:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE CREATES THE TEMPORARY STUDENT GOVERNMENT FINANCIAL RESTRUCTURE COMMITTEE; AND

**PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO ARLETTE HENDERSON, STUDENT GOVERNMENT FINANCIAL COORDINATOR, EDWARD PARFAIT, ASSISTANT DIRECTOR OF ACCOUNTING SERVICES, AND ERIC MONDAY, VICE CHANCELLOR OF FINANCE AND ADMINISTRATIVE SERVICES.

**PARAGRAPH 7:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
