10 **TO COMMEND THE IOTA PI CHAPTER OF THETA CHI FRATERNITY AS AN**

15 **PARAGRAPH 1:** WHEREAS, AN INITIAL INTEREST GROUP WAS FORMED TO
16 EXPLORE THE CREATION OF A CHAPTER OF THETA CHI

24 CHAPTER OF THETA CHI FRATERNITY ON APRIL 21, 2012 WITH
25 45 MEMBERS, AND;

27 **PARAGRAPH 4:** WHEREAS THE INTERFRATERNITY COUNCIL OF LOUISIANA
28 STATE UNIVERSITY WELCOMED THE IOTA PI CHAPTER OF THETA
29 CHI INTO ITS COUNCIL AS ITS 21ST MEMBER ON SEPTEMBER 26,
30 2012, AND;

32 **PARAGRAPH 5:** WHEREAS, JUSTIN JONES IS THE CURRENT PRESIDENT OF THE
33 IOTA PI CHAPTER OF THETA CHI, AND;

35 **PARAGRAPH 6:** WHEREAS, HE TOOK THE POSITION IN JANUARY 2012 AND WAS
36 THE PRESIDENT WHEN THE FRATERNITY WAS CHARTERED IN
37 APRIL AND WHEN IT WAS WELCOMED AS A MEMBER OF THE
