A BILL

TO AMEND THE STUDENT GOVERNMENT BYLAWS

PARAGRAPH 1: WHEREAS, THE STUDENT GOVERNMENT SENATE COMMITTEE ON FINANCE, IN ITS GOAL OF STUDENT GOVERNMENT ACCOUNTS REFORM HAS PROPOSED THE FOLLOWING AMENDMENTS; AND

PARAGRAPH 2: WHEREAS, THE STUDENT GOVERNMENT BYLAWS SHOULD READ AS FOLLOWS:

ARTICLE VIII

Financial Accounts

- A. Student Government Surplus
1. This account may only be used for one-time expenditures of Student Government.
 2. Funds may be requested by members of Student Government via a Bill introduced in and approved by the Senate and approved by the Student Body President, Dean of Students, and Vice-Chancellor of Student Life through a memorandum disseminated by the Student Body President.
 3. All remaining funds in Student Government Operating Accounts, with the exception of the College Councils Surplus Account, at the end of each fiscal year are transferred to the Student Government Surplus Account ~~and~~.
 4. **The Student Government Surplus Account shall not exceed thirty thousand dollars (\$30,000). The author of the Student Government Budget Bill during the temporary Senate Committee of Budget and Appropriations must estimate the amount of funds after the fiscal year that will be transferred after exceeding the Surplus Account cap. The Chair of the Senate Committee on Budget and Appropriations must amend the Student Government Budget Bill upon receiving the enrollment numbers from the Office of the Registrar. The remaining funds that exceed the cap will be allocated accordingly in the Student Government Operational Budget.**

PARAGRAPH 8: THEREFORE BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE AFOREMENTIONED AMENDMENTS TO THE STUDENT GOVERNMENT BYLAWS BE ADOPTED.

PARAGRAPH 9: THIS BILL SHALL TAKE EFFECT BY A TWO-THIRDS ($2/3$) VOTE OF THE STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE ON THE DATE OF SUCH APPROVAL.
