**A FINANCE BILL****TO ALLOCATE FOUR THOUSAND DOLLARS (\$4,000) FROM THE STUDENT SENATE  
CONTINGENCY ACCOUNT TO FUND A REFERENCE CENTER IN THE BUSINESS  
EDUCATION COMPLEX**

- PARAGRAPH 1:** WHEREAS, A REFERENCE CENTER WOULD PROVIDE BOOKS & CURRENT PUBLICATIONS FOR USE BY STUDENTS; AND
- PARAGRAPH 2:** WHEREAS, THE BUSINESS EDUCATION COMPLEX WAS DESIGNED TO FURTHER THE LEARNING OF STUDENTS BOTH IN AND OUT OF CLASS; AND
- PARAGRAPH 3:** WHEREAS, THE EJ OURSO COLLEGE OF ADMINISTRATION IS COMMITTED TO FUNDING FUTURE UPKEEP COSTS OF A THE BUSINESS COLLEGE REFERENCE CENTER; AND
- PARAGRAPH 4:** WHEREAS, THE EJ OURSO COLLEGE OF BUSINESS HAS RESERVED SPACE FOR THE REFERENCE CENTER IN A ROOM DESIGNATED AS THE COMMUNICATION ACROSS THE CURRICULUM CENTER; AND
- PARAGRAPH 5:** WHEREAS, THE FACULTY WOULD BE POLLED TO DETERMINE THE MOST RELEVANT BOOKS TO THEIR SUBJECT MATTER, CREATING A DIVERSE WEALTH OF KNOWLEDGE; AND
- PARAGRAPH 6:** WHEREAS, THE REFERENCE CENTER WOULD BE OPEN TO ANY STUDENT INTERESTED IN ENHANCING HIS OR HER KNOWLEDGE OF THE BUSINESS REALM; AND
- PARAGRAPH 7:** THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE THAT FOUR THOUSAND DOLLARS (\$4,000) BE ALLOCATED FROM THE STUDENT GOVERNMENT CONTINGENCY ACCOUNT TO FUND A REFERENCE CENTER FOR THE BUSINESS EDUCATION COMPLEX; AND
- PARAGRAPH 8:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
