A RESOLUTION

TO URGE AND REQUEST UNIVERSITY AUXILIARY SERVICES AND THE STUDENT UNION TO INVESTIGATE THE PLACEMENT OF WATER BOTTLE REFILL STATIONS IN THE STUDENT UNION TO ASSIST IN SUSTAINABILITY EFFORTS AND IN SAVING STUDENT COSTS

PARAGRAPH 1: WHEREAS, UNIVERSITY RECREATION HAS RECENTLY PLACED A WATER BOTTLE REFILL STATION AT THEIR FACILITIES; AND

PARAGRAPH 2: WHEREAS, THESE STATIONS HAVE THE POTENTIAL TO SAVE HUNDREDS AND POTENTIALLY THOUSANDS OF WATER BOTTLES TO AID IN ENVIRONMENTAL AND SUSTAINABILITY EFFORTS; AND

PARAGRAPH 3: WHEREAS, THE STUDENT GOVERNMENT IS CONSTANTLY IN SEARCH OF NEW AND INNOVATIVE WAYS TO MOVE THE UNIVERSITY IN A MORE SUSTAINABLE DIRECTION; AND

PARAGRAPH 4: WHEREAS, THE STUDENT SENATE MAY SUBSEQUENTLY DISTRIBUTE WATER BOTTLES TO STUDENTS THAT THEY MAY REFILL AT THESE NEW STATIONS; AND

PARAGRAPH 5: WHEREAS, THIS NEW SERVICE WILL ALSO AID IN THE SAVING OF STUDENTS' COSTS ON CAMPUS AS THEY WILL NOT HAVE TO PURCHASE WATER BOTTLES AT EVERY VISIT TO THE STUDENT UNION; AND

PARAGRAPH 6: WHEREAS, SEVERAL SCHOOLS WITHIN THE SEC HAVE PURSUED THIS INITIATIVE TO THE BETTERMENT OF THEIR RESPECTIVE CAMPUSES; AND

PARAGRAPH 7: THEREFORE, BE IT RESOLVED THAT THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE URGES AND REQUESTS UNIVERSITY AUXILIARY SERVICES AND THE STUDENT UNION TO INVESTIGATE THE PLACEMENT OF WATER BOTTLE REFILL STATIONS IN THE STUDENT UNION TO ASSIST IN SUSTAINABILITY EFFORTS AND IN SAVING STUDENT COSTS

PARAGRAPH 8: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE DELIVERED TO JASON TOLLIVER, DIRECTOR OF UNIVERSITY AUXILIARY SERVICES AND THE STUDENT UNION.

PARAGRAPH 9: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND

SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF
SUCH APPROVAL.
