A RESOLUTION

TO URGE AND REQUEST LSU RESIDENTIAL LIFE TO PROVIDE POSTERS ABOVE RECYCLE BINS INDICATING WHAT CAN AND CANNOT BE RECYCLED

PARAGRAPH 1: WHEREAS, THERE ARE CURRENTLY NO SIGNS THAT CLEARLY INDICATE WHAT CAN OR CANNOT BE PLACED IN RECYCLE BINS;

PARAGRAPH 2: WHEREAS, STUDENTS ARE DISPOSING OF TRASH IMPROPERLY IN RECYCLE BINS AND VICE VERSA;

PARAGRAPH 3: WHEREAS, THE LACK OF READILY AVAILABLE RECYCLING INFORMATION IS INHIBITING SUSTAINABLE PRACTICES WITHIN THE RESIDENTIAL HALLS AND APARTMENTS;

PARAGRAPH 4: WHEREAS, THESE POSTERS WOULD INCREASE RECYCLING WITHIN RESIDENTIAL HALLS AND APARTMENTS BY EDUCATING THE RESIDENTS

PARAGRAPH 5: THEREFORE, BE IT RESOLVED BY THE STUDENT SENATE OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE THAT LSU RESIDENTIAL LIFE PROVIDE POSTERS ABOVE RECYCLE BINS INDICATING WHAT CAN AND CANNOT BE RECYCLED

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE FORWARDED TO COLBY KINDER, CHAIR OF THE SUSTAINABILITY COMMITTEE OF LSU RESIDENTIAL LIFE

PARAGRAPH 7: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT; UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION; OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE.
