A RESOLUTION

TO URGE AND REQUEST THE OFFICE OF PARKING, TRAFFIC, AND TRANSPORTATION TO POST AN UPDATED MAP DENOTING THE LOCATION OF ALL BICYCLE PUMPS AND REPAIR STATIONS ON THE LSUMOBILE APPLICATION AS WELL AS MAKING LIMITED PAPER COPIES AVAILABLE UPON REQUEST AT THE PARKING OFFICE

PARAGRAPH 1: WHEREAS, THE KNOWLEDGE OF BIKE PUMP AND REPAIR STATION LOCATIONS AROUND CAMPUS IS IMPORTANT FOR MEMBERS OF THE CAMPUS COMMUNITY; AND

PARAGRAPH 2: WHEREAS, THIS KNOWLEDGE WOULD ENCOURAGE BICYCLE USE, THUS PROMOTING SUSTAINABLE TRANSPORTATION; AND

PARAGRAPH 3: WHEREAS, A VERSION OF THIS MAP IS CURRENTLY POSTED ON THE PARKING OFFICE WEBSITE; AND

PARAGRAPH 4: WHEREAS, SIGNAGE SHOULD BE PLACED ABOVE ALL STATIONS DIRECTING STUDENTS TO RELEVANT CONTACT INFORMATION FOR REPAIRS;

PARAGRAPH 5: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE URGES AND REQUESTS THE LSU OFFICE OF PARKING, TRAFFIC, AND TRANSPORTATION TO POST AN UPDATED MAP DENOTING THE LOCATION OF ALL BICYCLE PUMPS AND REPAIR STATIONS ON THE LSUMOBILE APPLICATION AS WELL AS MAKING LIMITED PAPER COPIES AVAILABLE UPON REQUEST AT THE PARKING OFFICE

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE DELIVERED TO GARY GRAHAM, DIRECTOR OF PARKING, TRAFFIC, AND TRANSPORTATION

PARAGRAPH 7: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
