A RESOLUTION

PARAGRAPH 6: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE THAT THE NORTH GATE FUN RUN IS SUPPORTED AND
