A FINANCE BILL

TO ALLOCATE A MAXIMUM OF SEVENTEEN HUNDRED DOLLARS (\$1,700) FROM THE SENATE CONTINGENCY ACCOUNT TO FUND THE GOING GLOBAL PROGRAM AT LSU

PARAGRAPH 1: WHEREAS, LOUISIANA STATE UNIVERSITY HAS BECOME ONE OF THE TOP UNIVERSITIES IN THE NATION WITH USING GOING GLOBAL; AND

PARAGRAPH 2: WHEREAS, GOING GLOBAL HAS HELPED COUNTLESS STUDENTS FIND JOBS AND INTERNSHIPS ACROSS THE WORLD AND HAS HELPED PREPARE STUDENTS FOR THESE JOBS AND INTERNSHIPS; AND

PARAGRAPH 3: WHEREAS, THERE IS CURRENTLY A BALANCE FOR APPROXIMATELY TWENTY NINE THOUSAND DOLLARS (\$29,000) IN THE SENATE CONTINGENCY ACCOUNT; AND

PARAGRAPH 4: WHEREAS, THERE HAVE BEEN TEN THOUSAND ONE HUNDRED AND FIVE (10,105) STUDENTS IN THE PAST YEAR ALONE TO USE THIS PROGRAM AND APPROXIMATELY FORTY FOUR THOUSAND SIX HUNDRED AND TWENTY FIVE (44,625) HAVE USED THE PROGRAM IN THE PAST FEW YEARS

PARAGRAPH 5: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE THAT A MAXIMUM OF SEVENTEEN HUNDRED DOLLARS (\$1,700) BE ALLOCATED FROM THE SENATE CONTINGENCY ACCOUNT TO FUND THE GOING GLOBAL PROGRAM AT LSU, AND

PARAGRAPH 6: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
