A RESOLUTION

TO URGE AND REQUEST THE CITY OF BATON ROUGE TO ADD AND REPAIR SIDEWALKS AND LIGHTING TO THE NORTHGATES OF LSU

PARAGRAPH 1: WHEREAS, THE POSITIVE CONDITION AND DEVELOPMENT OF THE NORTHGATE AREA IS ESSENTIAL FOR RECRUITING AND RETAINING TALENT TO LOUISIANA STATE UNIVERSITY; AND

PARAGRAPH 2: WHEREAS, THE LACK OF ADEQUATE SIDEWALKS AND LIGHTING POSE AN IMMENSE SAFETY HAZARD ON LSU STUDENTS AND FACULTY LIVING AND WALKING IN THE AREA; AND

PARAGRAPH 3: WHEREAS, THE ACCOMPANYING PHOTOS ARE EVIDENCE OF THE INADEQUACY OF THE INFRASTRUCTURE OF THE NORTHGATE AREA; AND

PARAGRAPH 4: WHEREAS, LSU STUDENTS ARE VOTING MEMBERS OF METRO COUNCIL DISTRICT 10 AND OF THE CITY OF BATON ROUGE;

PARAGRAPH 5: THEREFORE, BE IT RESOLVED THAT THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE URGE AND REQUEST THE CITY OF BATON ROUGE TO ADD AND REPAIR SIDEWALKS AND LIGHTING IN THE NORTHGATES OF LSU.

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT THIS RESOLUTION BE FORWARDED TO TARA WICKER, METRO COUNCILWOMAN; THE RESIDENTIAL LIFE DIRECTOR; KIP HOLDEN, MAYOR; MICHAEL V. MARTIN, CHANCELLOR; THE DEPARTMENT OF PUBLIC WORKS; BRAC; AND VARIOUS NORTHGATE MERCHANTS.

PARAGRAPH 7: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
