### A BILL

## TO AMEND RULE 6.4 OF THE SENATE RULES OF ORDER

PROPERLY EXHIBITED FOR ALL TO SEE ITS LUMINOUS

**PARAGRAPH 5:** WHEREAS, THE SENATE COMMITTEE OF CAMPUS SERVICES

AND DEVELOPMENT WILL CONTINUE TO MAKE HISTORY BY LEADING THE WAY FOR STUDENTS THROUGH THE DARKNESS OF

LSU CAMPUS(I.E. "LUMOS, "MUGGLES BEWARE); AND

# Rule 6.4 Referral to Standing Committees

CAMPUS SERVICES AND DEVELOPMENT: The motto of this committee is "While other committees pass legislation, CSD saves lives." The motto shall appear on all official committee correspondence. To this committee shall be referred all legislation and other matters relating to the following subjects:

- All matters relating to on-campus housing, including the Residence Halls, and Greek housing.
- 2. The construction, demolition, or modification of structures or areas on campus.
- 3. Facility Planning.
- Facility Services.
- 5. The Information Technology Master Plan.
- 6. The University Master Plan.

- 7. The purchase, sale, modification, or use of university technology.
- 8. Information Technology Services.
- 9. The Student Technology Fee, with the exception of increases or decreases of the Fee itself.
- 10. Issues pertaining to sustainability and conservation.
- 11. All issues relating to campus parking, traffic, and transportation.
- 12. Other matters as ordered by the Student Senate.

PARAGRAPH 8: THEREFORE, BE IT ENACTED BY THE STUDENT

GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE THAT

THE SENATE RULES OF ORDER BE THUS AMENDED.

PARAGRAPH 9: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS

(2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
