**A RESOLUTION**

**TO URGE AND REQUEST THE ADMINISTRATION OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE TO SUPPORT THE REFORMATION OF THE PSIF AND ORF FUNDING COMMITTEES, AS OUTLINED IN THE EXECUTIVE MEMO, IN ORDER TO SIMPLIFY AND STREAMLINE THE STUDENT FUNDING PROCESS**

**PARAGRAPH 1:** WHEREAS, THE CURRENT PSIF AND ORF FUNDING PROCESSES AND STIPULATIONS ARE COMPLICATED AND BURDENSOME TO THE STUDENTS, AND

**PARAGRAPH 2:** WHEREAS, STUDENTS WHO SEEK FUNDING FROM THESE TWO ACCOUNTS ARE OFTEN CONFUSED BY THE DIFFERENT TERMS AND CONDITIONS THAT PERTAIN TO EACH RESPECTIVE ACCOUNT, AND

**PARAGRAPH 3:** WHEREAS, IT IS THE RESPONSIBILITY OF STUDENT GOVERNMENT TO PROMOTE THE INTERESTS OF THE STUDENT BODY, AND

**PARAGRAPH 4:** WHEREAS, THE STUDENTS WOULD BE BETTER SERVED BY ONE COMPREHENSIVE FUNDING PROCESS, AND

**PARAGRAPH 5:** WHEREAS, ONE SINGLE FUNDING COMMITTEE OVERSEEING BOTH THE ORF AND PSIF ACCOUNTS WOULD STREAMLINE THE FUNDING PROCESS FOR STUDENTS.

**PARAGRAPH 6:** THEREFORE, BE IT RESOLVED THAT THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE URGE AND REQUEST THE ADMINISTRATION OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE TO SUPPORT THE REFORMATION OF THE PSIF AND ORF FUNDING COMMITTEES, AS OUTLINED IN THE EXECUTIVE MEMO, IN ORDER TO SIMPLIFY AND STREAMLINE AND THE STUDENT FUNDING PROCESS;

**PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO MICHAEL MARTIN, CHANCELLOR OF LOUISIANA STATE UNIVERSITY; KURT KEPPLER, VICE CHANCELLOR OF STUDENT LIFE AND ENROLLMENT SERVICES; K.C. WHITE, ASSOCIATE VICE CHANCELLOR AND DEAN OF STUDENTS; ERIC MONDAY, VICE CHANCELLOR OF

FINANCE AND ADMINISTRATIVE; AND DONNA TORRES, ASSOCIATE VICE CHANCELLOR OF FINANCE AND ADMINISTRATIVE SERVICES.

**PARAGRAPH 8:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2) VOTE OF THE LSU A&M STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
