A RESOLUTION

TO URGE AND REQUEST THE OFFICE OF PARKING, TRAFFIC AND TRANSPORTATION TO EXTEND THE HOURS OF CAMPUS TRANSIT OPERATIONS DURING FINALS WEEK

PARAGRAPH 1: WHEREAS, THE LIBRARY EXTENDS THEIR HOURS TO 24 HOURS OF OPERATION DURING FINALS WEEK; AND

PARAGRAPH 2: WHEREAS, MANY STUDENTS UTILIZE THESE HOURS TO STUDY FOR THEIR FINALS; AND

PARAGRAPH 3: WHEREAS, THE NIGHT ROUTES OF TIGER TRAILS ENDS THEIR OPERATION AT 3:00AM;

PARAGRAPH 4: WHEREAS, THERE IS A NEED FOR A SERVICE TO RUN BETWEEN THE HOURS OF 3:00AM AND 7:00AM, WHEN TIGER TRAILS RESUMES SERVICE; AND

PARAGRAPH 5: WHEREAS, CAMPUS TRANSIT WOULD BE A LOGICAL OUTLET OF SERVICE TO FILL THIS GAP;

PARAGRAPH 6: THEREFORE, BE IT RESOLVED THAT THE STUDENT SENATE OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE URGES AND REQUESTS THE OFFICE OF PARKING, TRAFFIC AND TRANSPORTATION TO EXTEND THE OPERATION HOURS OF CAMPUS TRANSIT FROM 3:00AM UNTIL 7:00AM DURING FINALS WEEKS.

PARAGRAPH 7: BE IT FURTHER RESOLVED THAT A SUITABLE COPY OF THIS RESOLUTION BE FORWARDED TO GARY GRAHAM, DIRECTOR OF THE OFFICE OF PARKING, TRAFFIC AND TRANSPORTATION.

PARAGRAPH 8: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
