**A RESOLUTION**

**TO URGE AND REQUEST THAT ALL METERED PARKING SPACES ON CAMPUS ARE IN SERVICE BETWEEN THE HOURS OF 7:00AM AND 4:30PM ON WEEKDAYS.**

- PARAGRAPH 1:** WHEREAS, THE PARKING METERS ARE CURRENTLY IN SERVICE BETWEEN THE HOURS OF 7:00 AM AND 10:00 PM ON WEEKDAYS; AND
- PARAGRAPH 2:** WHEREAS, THE HOURS OF OPERATION FOR ZONE PARKING ARE 7:00 AM TO 4:30 PM ON WEEKDAYS; AND
- PARAGRAPH 3:** WHEREAS, ALIGNING THE HOURS OF OPERATION OF THE METER PARKING SPACES AND THE ZONE PARKING SPACES WILL CLARIFY THE PARKING HOURS ON CAMPUS; AND
- PARAGRAPH 4:** WHEREAS, ALIGNING THE HOURS OF OPERATION OF THE METER PARKING SPACES AND THE ZONE PARKING SPACES WILL EQUIVOCATE THE PARKING HOURS ON CAMPUS; AND
- PARAGRAPH 5:** THEREFORE, BE IT RESOLVED THAT THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE URGE AND REQUEST THAT ALL METERED PARKING SPACES ON CAMPUS ARE IN SERVICE BETWEEN THE HOURS OF 7AM AND 4:30PM BY THE MEANS DEFINED ABOVE.
- PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A SUITABLE COPY OF THIS RESOLUTION BE FORWARDED TO GARY GRAHAM, DIRECTOR OF LSU PARKING, TRAFFIC, AND TRANSPORTATION, FANNIE MONCRIEFFE, ASSOCIATE DIRECTOR OF LSU PARKING, TRAFFIC, AND TRANSPORTATION, ERIC REID, ASSISTANT DIRECTOR OF LSU PARKING, TRAFFIC, AND TRANSPORTATION, AND MICHAEL MARTIN, CHANCELLOR.
- PARAGRAPH 7:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT; UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION; OR IF VETOED BY THE PRESIDENT, AND SUBSEQUENTLY APPROVED BY THE SENATE.
