A RESOLUTION

TO THANK ATHLETIC DIRECTOR JOE ALLEVA, LES MILES, TRENT JOHNSON AND PAUL MAINIERI FOR EACH DONATING ONE THOUSAND DOLLARS (\$1,000) FOR STUDENT TICKETS FOR THE WOMEN’S NCAA BASKETBALL TOURNAMENT.

PARAGRAPH 1: WHEREAS, THE WOMEN’S BASKETBALL TEAM ENTERED THE NATIONAL COLLEGIATE ATHLETIC ASSOCIATION BASKETBALL TOURNAMENT IN MARCH; AND

PARAGRAPH 2: WHEREAS, WHEREAS, IT IS AGAINST NCAA REGULATIONS TO HAVE FREE ADMISSION FOR STUDENTS; AND

PARAGRAPH 3: WHEREAS, ATHLETIC DIRECTOR JOE ALLEVA FELT IT NECESSARY TO ENCOURAGE STUDENTS TO ATTEND THEIR GAMES TO CHEER THEM ON; AND

PARAGRAPH 4: WHEREAS, COACHES LES MILES, TRENT JOHNSON AND PAUL MAINIERI FELT THAT WITH THEIR SEASONS UNDERWAY THAT THEY COULD NOT BE THERE TO ATTEND.

PARAGRAPH 5: THEREFORE, BE IT RESOLVED THAT THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE TO THANK ATHLETIC DIRECTOR JOE ALLEVA, LES MILES, TRENT JOHNSON AND PAUL MAINIERI FOR EACH DONATING ONE THOUSAND DOLLARS (\$1,000) FOR STUDENT TICKETS FOR THE WOMEN’S NCAA BASKETBALL TOURNAMENT.

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT THIS BE SENT TO THE ATHLETIC DEPARTMENT, THE OFFICES OF JOE ALLEVA, LES MILES, TRENT JOHNSON, AND PAUL MAINIERI.

PARAGRAPH 7: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
