A BILL
TO AMEND THE STUDENT GOVERNMENT BYLAWS.

PARAGRAPH 1: WHEREAS, ALL STUDENT SENATORS ARE REQUIRED TO OBTAIN FOUR OUTREACH POINTS THROUGHOUT THE SEMESTER AND OFTEN FIND IT DIFFICULT TO INDIVIDUALLY COORDINATE ORGANIZATION VISITS ONCE THE SEMESTER BEGINS; AND

PARAGRAPH 2: WHEREAS, THE EXECUTIVE BRANCH WILL HANDLE STUDENT ORGANIZATIONAL OUTREACH, AND WILL COORDINATE WITH THE CHAIR OF STUDENT LIFE, DIVERSITY, AND COMMUNITY OUTREACH WHEN SENATORS ARE NEEDED AT AN ORGANIZATION VISIT; AND

PARAGRAPH 3: WHEREAS, EVERY STUDENT SENATOR HAS THE OBLIGATION TO EARN FOUR (4) STUDENT OUTREACH POINTS, AND ALL FOUR MAY BE OBTAINED THROUGH CAMPUS AND COMMUNITY EVENTS APPROVED BY THE CHAIR AND VICE-CHAIR OF THE STUDENT LIFE, DIVERSITY, AND COMMUNITY OUTREACH COMMITTEE; AND

PARAGRAPH 4: THE BYLAWS SHALL BE AMENDED TO READ AS FOLLOWS:

Article III Section 1D

All members of LSU Student Government (SG) must obtain a minimum of Four (4) student outreach points. All members of the Senate shall be willing to coordinate with the Executive Branch and the Chair of the Student Life, Diversity, and Community Outreach for Organization Visits as needed. Senators may still coordinate their own organization visits for a student outreach point with the approval and assistance of the Student Life, Diversity, and Community outreach Committee Chair and Vice-Chair; and

PARAGRAPH 5: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE ABOVE AMENDMENTS BE ADOPTED INTO THE LSU STUDENT GOVERNMENT BYLAWS, AND

PARAGRAPH 6: BE IT RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO THE LSU THE LSU STUDENT GOVERNMENT CHIEF JUSTICE, AND

PARAGRAPH 7: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
