A RESOLUTION

TO URGE AND REQUEST THE LSU ATHLETIC DEPARTMENT TO DISTRIBUTE THE STUDENT-ATHLETE ADVISORY COMMITTEE (SAAC) SURVEY TO STUDENT ATHLETES.

- PARAGRAPH 1:** WHEREAS, SAAC SERVES AS THE GOVERNING BODY FOR LSU STUDENT-ATHLETES; AND
- PARAGRAPH 2:** WHEREAS, THE ROLE OF EACH MEMBER IS TO REPRESENT HIS OR HER TEAM IN TERMS OF COMMUNICATING INFORMATION TO THE ADMINISTRATION STAFF AND COACHES; AND
- PARAGRAPH 3:** WHEREAS, SAAC CAN'T EFFECTIVELY DISCUSS AND TAKE ACTION ON ISSUES RELATING TO RULES GOVERNANCE, STUDENT-ATHLETE WELFARE, AND COMMUNITY SERVICE INITIATIVES WITHOUT PROPERLY ASSESSING THE NEEDS OF EACH INDIVIDUAL ATHLETE.; AND
- PARAGRAPH 4:** WHEREAS, ATHLETES HAVING ADVERSE EXPERIENCES MAY NOT FEEL COMFORTABLE COMMUNICATING DIRECTLY WITH COACHES OR ADMINISTRATION; AND
- PARAGRAPH 5:** WHEREAS, DENYING THE DISTRIBUTION OF THE SURVEY GOES AGAINST THE MISSION OF SAAC TO CREATE AN ENVIRONMENT WHERE ALL STUDENT-ATHLETES HAVE THE OPPORTUNITY TO MAXIMIZE THEIR ACADEMIC, ATHLETIC, PERSONAL, AND SOCIAL GROWTH AS WELL AS IMPROVE THEIR POST-COLLEGE QUALITY OF LIFE; AND
- PARAGRAPH 6:** THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE URGES AND REQUESTS THAT THE LSU ATHLETIC DEPARTMENT DISTRIBUTE THE STUDENT-ATHLETE ADVISORY COMMITTEE SURVEY TO STUDENT-ATHLETES, AND
- PARAGRAPH 7:** THEREFORE, BE IT RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO SENIOR ASSOCIATE ATHLETIC DIRECTOR/SWA, MIRIAM SEGAR, AND
- PARAGRAPH 8:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY

THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE
SENATE, ON THE DATE OF SUCH APPROVAL.
