7 A BILL

8 TO CREATE THE TEMPORARY POSITION OF STATISTICIAN TO COLLECT THE IDEAS AND
9 OPINIONS OF THE STUDENT BODY.

11 PARAGRAPH 1: WHEREAS, IT IS EXTREMELY DIFFICULT FOR ANY SENATOR TO
12 COLLECT INFORMATION WEEKLY ABOUT THE OPINIONS OF THEIR
13 CONSTITUENTS IN A SYSTEMATIC AND UNBIASED WAY; AND

15 PARAGRAPH 2: WHEREAS, IT IS THE RESPONSIBILITY OF THE SENATE TO
16 UNDERSTAND THE POSITION OF THEIR CONSTITUENTS IN ORDER
17 TO SERVE THEM EFFECTIVELY; AND

19 PARAGRAPH 3: WHEREAS, THIS POSITION SHALL NOT BE OPEN TO SOMEONE
20 WHO CURRENTLY HOLDS A POSITION IN STUDENT GOVERNMENT.
21 THIS POSITION SHALL BE ELECTED BY THE STUDENT SENATE BY A
22 MAJORITY (1/2) VOTE.

24 PARAGRAPH 4: WHEREAS, THIS POSITION SHALL BE IN EXISTENCE UNTIL THE
25 END OF THE SPRING 2009 SEMESTER.

27 PARAGRAPH 5: THEREFORE, BE IT ENACTED BY THE STUDENT
28 GOVERNMENT OF LOUISIANA STATE UNIVERSITY
29 AND AGRICULTURAL AND MECHANICAL COLLEGE
30 THAT THE POSITION OF STATISTICIAN IS CREATED WITH THE
31 DUTIES AS FOLLOWS:

33 THE STATISTICIAN'S SOLE RESPONSIBILITY IS TO
34 COLLECT INFORMATION AND OPINIONS FROM THE
35 STUDENT BODY IN AN UNBIASED AND STATISTICALLY
36 SIGNIFICANT MANNER. THE DATA TO BE COLLECTED
37 AND THE METHOD TO BE USED WILL BE DETERMINED
38 UPON THE PRESENTATION OF THE PARTICULAR
39 PROJECT BEING REQUESTED.

41 PARAGRAPH 5: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY
42 (1/2) OF THE LSU STUDENT SENATE AND SIGNATURE BY THE
43 PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR
44 IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY
45 THE SENATE, ON THE DATE OF SUCH APPROVAL.
