**A RESOLUTION**

**TO URGE AND REQUEST THAT THE COMMISSIONER OF THE SOUTHEASTERN CONFERENCE IMPLEMENT A GUEST TICKET POLICY FOR REGULAR SEASON CONFERENCE GAMES**

- PARAGRAPH 1:** WHEREAS, CURRENTLY THERE IS NO SUCH CONFERENCE POLICY STIPULATING MINIMUM TICKET REQUIREMENTS AND PLACEMENT FOR VISITING TEAMS.
- PARAGRAPH 2:** WHEREAS, THERE IS NO CONSISTENCY AMONG SCHOOLS OF THE SOUTHEASTERN CONFERENCE REGARDING PLACEMENT OF VISITING FANS.
- PARAGRAPH 3:** WHEREAS, CURRENTLY SCHOOLS RANGE FROM 1,500 TO 3,800 IN THE LOWER BOWLS OF EACH FOOTBALL STADIUM PLACING THE REST OF THE ALLOCATION IN THE UPPER DECK.
- PARAGRAPH 4:** WHEREAS, RECENTLY THE STUDENT SECTION FOR LOUISIANA STATE UNIVERSITY WAS SPLIT BETWEEN THE UPPER AND LOWER SECTIONS AT A VISITING STADIUM
- PARAGRAPH 5:** WHEREAS, THE REST OF THE LSU FANS WERE SEPARATED INTO FOUR DIFFERENT AREAS OF THE STADIUM ENTIRELY.
- PARAGRAPH 6:** THEREFORE, BE IT RESOLVED BY THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AND AGRICULTURAL AND MECHANICAL COLLEGE URGE AND REQUEST THE COMMISSIONER OF THE SOUTHEASTERN CONFERENCE DEVELOP AND IMPLEMENT A CONSISTENT GUEST TICKET POLICY FOR REGULAR SEASON CONFERENCE GAMES. WE ASK THAT THIS POLICY ALSO INCLUDE A MINIMUM OF 500 GUEST STUDENT TICKETS IN THE LOWER SECTION OF ALL SEC GAMES
- PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A SUITABLE COPY OF THIS RESOLUTION BE TRANSMITTED TO SEC COMMISSIONER MIKE SLIVE AND LSU ATHLETIC DIRECTOR SKIP BERTMAN
