16 **PARAGRAPH 1:** WHEREAS THE STUDENTS FOR REFORM ORGANIZATION IS A
17 REGISTERED STUDENT ORGANIZATION THAT PROVIDES FREE
18 COPIES OF ITS PUBLICATION THAT BOTH EDUCATE AND
19 ENTERTAIN THE STUDENT BODY, AND

21 **PARAGRAPH 2:** WHEREAS THE STUDENTS FOR REFORM PROVIDES A FREE
22 OUTLET FOR LSU STUDENTS TO PUBLISH THEIR WORKS, AND

24 **PARAGRAPH 3:** WHEREAS THE LSU STUDENT SENATE HAS FUNDED MEDIA
25 OUTLETS PREVIOUSLY WHEN THEY WERE FOUND TO INCREASE
26 THE ACADEMIC ATMOSPHERE OF THE CAMPUS

28 **PARAGRAPH 4:** THEREFORE, BE IT ENACTED BY THE STUDENT GOVERNMENT OF
29 LOUISIANA STATE UNIVERSITY AND AGRICULTURAL AND
30 MECHANICAL COLLEGE STUDENT SENATE WILL ALLOCATE
31 \$2,590.00 FROM THE INITIATIVES ACCOUNT TO ASSIST IN THE

35 **PARAGRAPH 5:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A THREE-

37 SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR
38 PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND
39 SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF
40 SUCH APPROVAL.
