7 **A RESOLUTION**

8 **TO URGE AND REQUEST THE LSU ATHLETIC DEPARTMENT TO REVISE THE POLICY ON**  
9 **IDENTIFICATION NECESSARY FOR STUDENTS TO BE ADMITTED TO TIGER STADIUM.**

10 **PARAGRAPH 1:** WHEREAS, A NEW POLICY WAS IMPLEMENTED IN REGARDS TO  
11 STUDENT TICKETS FOR LSU HOME FOOTBALL GAMES FOR THE  
12 CURRENT FOOTBALL SEASON, AND

13 **PARAGRAPH 2:** WHEREAS, THE POLICY IN PART REQUIRES STUDENTS TO PRINT  
14 THEIR OWN GAMEDAY TICKETS WHICH HAVE THEIR NAMES  
15 PRINTED ON THE FACE OF THE TICKET, AND

16 **PARAGRAPH 3:** WHEREAS, THE POLICY ALSO REQUIRES THAT STUDENTS PRESENT  
17 A STUDENT IDENTIFICATION CARD ISSUED BY THE TIGER CARD  
18 OFFICE TO GAIN ADMISSION TO THE STADIUM, AND

19 **PARAGRAPH 4:** WHEREAS, THERE ARE NO EXCEPTIONS TO THE POLICY OF  
20 REQUIRING A STUDENT IDENTIFICATION CARD, WHICH IS  
21 PROBLEMATIC IF A STUDENT HAS LOST OR HAD THEIR  
22 IDENTIFICATION CARD STOLEN BEFORE ARRIVING AT THE  
23 STADIUM AS THE TIGER CARD OFFICE IS CLOSED ON SATURDAYS  
24 AND A STUDENT WOULD BE UNABLE TO OBTAIN A NEW CARD  
25 BEFORE THE START OF THE GAME, AND

26 **PARAGRAPH 5:** WHEREAS, OTHER FORMS OF STATE-ISSUED IDENTIFICATION  
27 SUCH AS A DRIVER'S LICENSE, PASSPORT OR MILITARY  
28 IDENTIFICATION SHOULD BE ACCEPTED AS AN ALTERNATIVE TO  
29 STUDENT IDENTIFICATION CARDS.

30 **PARAGRAPH 6:** THEREFORE, BE IT RESOLVED BY THE STUDENT  
31 GOVERNMENT OF LOUISIANA STATE UNIVERSITY  
32 AND AGRICULTURAL AND MECHANICAL COLLEGE  
33 THAT WE URGE AND REQUEST THE LSU ATHLETIC  
34 DEPARTMENT TO ALLOW STUDENTS TO PRESENT OTHER FORMS  
35 OF IDENTIFICATION OTHER THAN A STUDENT IDENTIFICATION  
36 CARD IN ORDER TO GAIN ADMISSION TO TIGER STADIUM, AND

37 **PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A COPY OF THIS  
38 RESOLUTION BE TRANSMITTED TO SKIP BERTMAN, DIRECTOR OF  
39 ATHLETICS AND BRIAN BROUSSARD, DIRECTOR OF THE  
40 ATHLETIC TICKET OFFICE.

41 **PARAGRAPH 8:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A  
42 MAJORITY VOTE OF THE LSU STUDENT SENATE AND SIGNATURE  
43 BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL  
44 ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY  
45 APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
