7 **A RESOLUTION**

8 **TO URGE AND REQUEST THE STUDENT HEALTH CENTER TO RESEARCH AND DEVELOP**
9 **A PLAN OF ACTION TO INCLUDE DENTAL SERVICES, ONLINE APPOINTMENT**
10 **SCHEDULING, A FULL OPTICAL CLINIC AND AN ACUTE CARE CLINIC/EXTENDED HOURS.**

11 **PARAGRAPH 1:** WHEREAS, THE STUDENT HEALTH CENTER (SHC) IS THE
12 PRIMARY SOURCE OF HEALTH CARE FOR THE STUDENTS OF
13 LOUISIANA STATE UNIVERSITY. AND;

14 **PARAGRAPH 2:** WHEREAS, THE SHC DOES NOT CURRENTLY OFFER DENTAL
15 SERVICES, OTHER THAN REFERRAL TO AN OUTSIDE DENTIST, AND;

16 **PARAGRAPH 3:** WHEREAS, THE SHC DOES NOT CURRENTLY PROVIDE A
17 SELECTION OF CONTACT LENSES OR GLASSES THAT CAN BE
18 PURCHASED ON CAMPUS, AND;

19 **PARAGRAPH 4:** WHEREAS, THE SHC DOES NOT CURRENTLY OFFER ACUTE CARE
20 INTO THE LATE HOURS OF THE EVENING, AND;

21 **PARAGRAPH 5:** WHEREAS, THE STUDENT SENATE IS MINDFUL THAT MONEY IS A
22 HINDERING FACTOR IN THE AMOUNT OF SERVICES THAT ARE
23 OFFERED, AND;

24 **PARAGRAPH 6:** WHEREAS, A PROPOSAL IS REQUESTED FROM THE SHC THAT
25 WOULD ENCOMPASS THESE SERVICES AND MORE FOR THE
26 STUDENT SENATE TO REVIEW AND MAKE A RECOMMENDATION
27 TO THE REQUIRED FEE COMMITTEE.

28 **PARAGRAPH 7:** THEREFORE, BE IT RESOLVED BY THE STUDENT
29 GOVERNMENT OF LOUISIANA STATE UNIVERSITY
30 AND AGRICULTURAL AND MECHANICAL COLLEGE
31 DOES HEREBY URGE AND REQUEST THAT THE
32 STUDENT HEALTH CENTER BEGIN A PLAN OF
33 ACTION TO ENCOMPASS THE ABOVE ACTION ITEMS.

35 RESOLUTION BE TRANSMITTED TO ART GOULAS,
36 DIRECTOR OF THE STUDENT HEALTH CENTER AND
