A BILL

TO APPROPRIATE ONE THOUSAND FOUR HUNDRED AND FOUR DOLLARS (\$1,404.00) TO COLLEGIATE 4-H AT LOUISIANA STATE UNIVERSITY FOR THE PURPOSE OF DEFRAYING THE COST OF TRAVEL, REGISTRATION AND LODGING FOR THE SOUTHERN REGIONAL COLLEGIATE 4-H CONFERENCE IN STILLWATER, OKLAHOMA

- PARAGRAPH 1:** WHEREAS, COLLEGIATE 4-H AT LOUISIANA STATE UNIVERSITY IS A REGISTERED STUDENT ORGANIZATION WITH THE CENTER FOR STUDENT LEADERSHIP AND INVOLVEMENT AND IS IN GOOD STANDING, AND
- PARAGRAPH 2:** WHEREAS, COLLEGIATE 4-H AT LSU HAS WON NUMEROUS AWARDS OVER THE PAST FEW YEARS INCLUDING REGIONAL CLUB OF THE YEAR MULTIPLE TIMES, AND
- PARAGRAPH 3:** WHEREAS, COLLEGIATE 4-H AT LSU IS HOME TO THE CURRENT SOUTHERN REGIONAL COLLEGIATE 4-H PRESIDENT, PATRICK VOORHIES, SOUTHERN REGIONAL SECRETARY, JACQUELINE SLAUGHTER, AND NATIONAL BUSINESS MANAGER, DERRICK GOEBEL, AND
- PARAGRAPH 4:** WHEREAS, LSU HOSTED THE 2003 SOUTHERN REGIONAL COLLEGIATE 4-H CONFERENCE WHERE APPROXIMATELY 50 STUDENTS FROM VARIOUS COLLEGES AND UNIVERSITIES MET ON THE CAMPUS OF LSU FOR BUSINESS MEETINGS AND SERVICE ACTIVITIES, AND
- PARAGRAPH 5:** WHEREAS, COLLEGIATE 4-H AT LSU IS VERY ACTIVE IN THE COMMUNITY, ASSISTING 4-H AND 4-H JUNIOR LEADER CLUBS THROUGHOUT LOUISIANA,
- PARAGRAPH 6:** THEREFORE, BE IT ENACTED BY THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AND AGRICULTURAL AND MECHANICAL COLLEGE TO APPROPRIATE ONE THOUSAND FOUR HUNDRED AND FOUR DOLLARS (\$1,404.00) TO COLLEGIATE 4-H AT LOUISIANA STATE UNIVERSITY TO DEFRAY THE COST OF TRAVEL, REGISTRATION AND LODGING FOR THE 2005 SOUTHERN REGIONAL COLLEGIATE 4-H CONFERENCE
- PARAGRAPH 7:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A THREE-FOURTHS ($3/4$) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
- PARAGRAPH 8:** ALL MONIES NOT EXPENDED BY THE END OF THE 2005-2006 FISCAL YEAR WILL REVERT TO THE SENATE GENERAL CONTINGENCY. SHOULD ANY PROVISION OF ARTICLE VI SECTIONS 14 THROUGH 17 OF THE STUDENT GOVERNMENT BYLAWS BE VIOLATED, RIGHTS TO GRANTED FUNDING WILL BE FORFEITED AND THIS BILL SHALL BECOME NULL AND VOID, UNLESS OTHERWISE PROVIDED IN THE RULES.
