11 **TO AMEND RULE 6.7 OF THE STUDENT SENATE RULES OF ORDER TO PLACE**  
12 **LIMITATIONS ON PUBLIC INPUT**

15 **PARAGRAPH 1:** BE IT ENACTED BY THE STUDENT GOVERNMENT OF  
16 LOUISIANA STATE UNIVERSITY AND AGRICULTURAL  
17 AND MECHANICAL COLLEGE THAT RULE 6.7 OF THE  
18 STUDENT SENATE RULES OF ORDER SHALL BE AMENDED AS  
19 FOLLOWS:

21 **Rule 6.7 Public Input; Limitations**

22  
23 Any student requesting Public Input before a meeting of  
24 the Student Senate is called to order shall be allotted a maximum  
25 of three (3) minutes in which they may speak. **Any member of**  
26 **Student Government giving an executive or judicial officer**  
27 **Report and any Senator speaking in proposition or**  
28 **opposition of legislation must obtain approval from the**  
29 **Speaker of the Senate prior to the Senate meeting in order to**  
30 **speak during public input.**

32 **PARAGRAPH 2:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS  
33 (2/3) VOTE OF THE LSU A&M STUDENT SENATE AND  
34 SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR  
35 PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND  
36 SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF  
37 SUCH APPROVAL.
