**A BILL**

**TO APPROPRIATE ONE THOUSAND ONE HUNDRED AND THREE DOLLARS (\$1,103.00) TO THE CIRCLE K CLUB OF LSU TO HELP DEFRAY THE COST OF REGISTRATION, TRANSPORTATION, AND LODGING TO ATTEND THE LOUISIANA-MISSISSIPPI-WEST TENNESSEE DISTRICT CONVENTION TO BE HELD IN MEMPHIS, TENNESSEE FROM MARCH 12 THROUGH MARCH 14,2004.**

- PARAGRAPH 1:** WHEREAS, THE CIRCLE K CLUB OF LOUISIANA STATE UNIVERSITY IS A RECOGNIZED STUDENT ORGANIZATION IN GOOD STANDING, AND
- PARAGRAPH 2:** WHEREAS, MEMBERSHIP IN THE CIRCLE K CLUB OF LSU IS OPEN TO ALL LSU STUDENTS, AND
- PARAGRAPH 3:** WHEREAS, THE STUDENT BODY WILL BENEFIT FROM THIS FUNDING IN THAT THE ATTENDEES WILL BE BETTER EQUIPPED TO SERVE THE LSU COMMUNITY THROUGH VOLUNTEER SERVICE, AND
- PARAGRAPH 4:** WHEREAS, THE CIRCLE K CLUB OF LSU HAS WON NUMEROUS AWARDS THROUGHOUT THE DISTRICT AND INTERNATIONAL-LEVELS, INCLUDING FOUR OUT OF FIVE OFFICER AWARDS IN THEIR RESPECTIVE OFFICES LAST YEAR, THE HIGHEST AWARD THAT CAN BE BESTOWED TO ANY OFFICER, AND
- PARAGRAPH 5:** WHEREAS, THE APPROXIMATE COST OF SENDING NINE DELEGATES IN ONE-THOUSAND, SEVEN HUNDRED SEVENTY-EIGHT DOLLARS (\$1,778.00), AND
- PARAGRAPH 6:** WHEREAS, THE CIRCLE K CLUB OF LSU HAS DONE VARIOUS FUNDRAISERS AND HAS SOLICITED DONATIONS FROM OTHER SOURCES, AND
- PARAGRAPH 7:** WHEREAS, THE CIRCLE K CLUB OF LSU IS STILL IN NEED.
- PARAGRAPH 8:** THEREFORE BE IT RESOLVED THAT THE LSU A&M STUDENT SENATE DOES HEREBY APPROPRIATE ONE-THOUSAND, ONE HUNDRED AND THREE DOLLARS (\$1,103.00) TO THE CIRCLE K CLUB OF LSU TO HELP DEFRAY THE COST OF ATTENDING THE LAMISSTENN DISTRICT CONVENTION.
- PARAGRAPH 7:** THIS BILL SHALL BE ENROLLED UPON A MAJORITY VOTE OF THE LSU A&M STUDENT SENATE. ALL MONIES NOT USED SHALL REVERT BACK TO THE GENERAL CONTINGENCY. THIS BILL SHALL BE NULL AND VOID AS OF JUNE 30, 2004.
