A BILL

TO AMEND CHAPTER 5 OF THE LSU A&M STUDENT SENATE RULES OF ORDER TO INCLUDE EX-OFFICIO ACADEMIC COMMITTEE REPRESENTATION OF THE HONORS COLLEGE.

PARAGRAPH 1: WHEREAS, THE HONORS COLLEGE IS AN INFLUENTIAL AND IMPORTANT PART OF LSU, AND

PARAGRAPH 2: WHEREAS, CURRENTLY, THERE IS NO GUARANTEED REPRESENTATION OF THE HONORS COLLEGE IN STUDENT GOVERNMENT, OTHER THAN THE PRESIDENTS CABINET AND THE CAMPUS SERVICE COUNCIL, AND

PARAGRAPH 3: WHEREAS, OTHER ORGANIZATIONS, SUCH AS THE RESIDENCE HALLS ASSOCIATION, HAVE GAINED FURTHER REPRESENTATION THROUGH EX-OFFICIO COMMITTEE SEATS, AND

PARAGRAPH 4: WHEREAS, THE ACADEMICS COMMITTEE IS THE MOST PERTINENT STANDING COMMITTEE TO THE AFFAIRS OF THE HONORS COLLEGE.

PARAGRAPH 5: THEREFORE, BE IT RESOLVED THAT RULE 5.3 OF THE LSU A&M STUDENT SENATE RULES OF ORDER SHALL BE AMENDED TO INCLUDE:

D. THE PRESIDENT OF THE HONORS COLLEGE STUDENT COUNCIL, OR HIS-HER DESIGNEE, SHALL BE AN EX-OFFICIO MEMBER OF THE ACADEMICS COMMITTEE.
