A BILL

TO APPROPRIATE TWO THOUSAND DOLLARS (\$2000) TO THE COLLEGE REPUBLICAN ALLIANCE FOR THE PURPOSE OF BRINGING BEN STEIN TO THE LSU CAMPUS FOR A LECTURE AND COMEDY ACT.

PARAGRAPH 1: WHEREAS, THE COLLEGE REPUBLICAN ALLIANCE IS PLANNING TO BRING BEN STEIN TO THE LSU CAMPUS IN SPRING OF 2002, AND

PARAGRAPH 2: WHEREAS, THIS ORGANIZATION HAS NEVER COME TO THE LSU A&M STUDENT SENATE FOR FUNDING, AND

PARAGRAPH 3: WHEREAS, HIS "WIN BEN STEIN'S INTELLECT" LECTURE WILL BE GIVEN EXCLUSIVELY AT LOUISIANA STATE UNIVERSITY, AND

PARAGRAPH 4: WHEREAS, THE COLLEGE REPUBLICAN ALLIANCE HAS GONE TO OTHER SOURCES FOR FUNDING, AND

PARAGRAPH 5: WHEREAS, THIS LECTURE WILL ENTERTAIN AND INFORM THE LSU STUDENT COMMUNITY.

PARAGRAPH 6: THEREFORE, THE LSU A&M STUDENT SENATE APPROPRIATES TWO THOUSAND DOLLARS (\$2000) TO THE COLLEGE REPUBLICAN ALLIANCE FOR THE PURPOSE OF BRINGING BEN STEIN TO THE LSU CAMPUS.

PARAGRAPH 7: ALL UNUSED FUNDS SHALL REVERT TO THE GENERAL CONTINGENCY. THIS BILL SHALL BE NULL AND VOID AS OF JUNE 30, 2002.
