A RESOLUTION

TO RECOMMEND TO THE ADMINISTRATION OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE TO ENACT A POLICY WHEREBY ANY STUDENT, FACULTY, STAFF OR VISITOR CAUGHT LITTERING CIGARETTE BUTTS ON CAMPUS MUST PAY A FINE OR DO COMMUNITY SERVICE CONSISTING OF PICKING UP CIGARETTE BUTTS.

PARAGRAPH 1: WHEREAS, SOME OF THE MOST OFFENSIVE DEGRADATION OF LOUISIANA STATE UNIVERSITY'S CAMPUS CONSISTS OF USED CIGARETTE BUTTS THAT HAVE BEEN THROWN ONTO THE GROUND AND EMPTY CIGARETTE BOXES LEFT ON BENCHES, AND

PARAGRAPH 2: WHEREAS, IF THE LITTERING OF CIGARETTE BUTTS WERE CONSIDERABLY CUT DOWN THE CAMPUS AS A WHOLE WOULD BE A MORE ATTRACTIVE PLACE FOR STUDENTS, FACULTY, STAFF, AND VISITORS ALIKE, AND

PARAGRAPH 3: WHEREAS, TOSSING CIGARETTE BUTTS ONTO THE GROUND IS NOT ONLY LITTER BUT IS A POTENTIAL FIRE HAZARD AND COULD IN FACT HARM THE ENTIRE CAMPUS ENVIRONMENT, AND

PARAGRAPH 4: WHEREAS, LSU RECENTLY SPENT A CONSIDERABLE AMOUNT OF MONEY ON COBBLESTONE STYLE ASH TRAYS AND GARBAGE CANS TO PLACE ALL OVER CAMPUS IN AN EFFORT TO REDUCE SUCH LITTER, YET THE CRIME IS STILL COMMITTED ON AN EXCESSIVE BASIS, AND

PARAGRAPH 5: WHEREAS, EITHER BY MEANS OF A FINE OR CAMPUS SERVICE, THIS POLICY WILL ENSURE A MORE ATTRACTIVE CAMPUS AND A BETTER PLACE TO GET AN EDUCATION.
