A BILL

TO AMEND ARTICLE VI, SECTION 1 OF THE LSU A&M STUDENT GOVERNMENT ELECTION CODE AS IT PERTAINS TO THE POLLING LOCATIONS OF THE MASS COMMUNICATIONS COLLEGE AND THE MUSIC AND DRAMATIC ARTS COLLEGE.

PARAGRAPH 1: ARTICLE VI, SECTION 1, SUBSECTIONS G AND H SHALL BE ADDED TO THE ELECTION CODE, AND

PARAGRAPH 2: ARTICLE VI, SECTION 1, SHALL READ:

“EIGHT POLLING PLACES WILL BE UTILIZED AS FOLLOWS, WITH THE ACADEMIC AREAS ALLOWED TO VOTE IN EACH LISTED TO THE SIDE:

- A. NORTH END OF THE QUADRANGLE--ARTS AND SCIENCES, GRADUATE SCHOOL, JUNIOR DIVISION, AND EDUCATION
- B. NEW DESIGN BUILDING--DESIGN AND GENERAL COLLEGE
- C. CEBA--BUSINESS AND ENGINEERING
- D. VET SCHOOL--VET SCHOOL
- E. CHOPPIN HALL--BASIC SCIENCES
- F. TUREAUD HALL--AGRICULTURE
- G. JOURNALISM BUILDING--MASS COMMUNICATIONS
- H. M&DA BUILDING--MUSIC AND DRAMATIC ARTS”

PARAGRAPH 3: THIS BILL SHALL BECOME EFFECTIVE TWO (2) SEMESTERS, EXCLUDING SUMMERS, FOLLOWING PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE STUDENT SENATE.
