A BILL

TO APPROPRIATE SEVEN HUNDRED FORTY-FIVE DOLLARS (\$745.00) TO THE POLITICAL SCIENCE GRADUATE ASSOCIATION TO DEFRAY THE COSTS OF SPONSORING THE 2000 FAITH AND REASON SYMPOSIUM.

PARAGRAPH 1: WHEREAS, THE POLITICAL SCIENCE GRADUATE ASSOCIATION IS A RECOGNIZED STUDENT ORGANIZATION, AND

PARAGRAPH 2: WHEREAS, THE 2000 FAITH AND REASON SYMPOSIUM WILL OCCUR AT LSU ON APRIL 10-11, AND

PARAGRAPH 3: WHEREAS, THE POLITICAL SCIENCE GRADUATE ASSOCIATION AND THE DEPARTMENT OF POLITICAL SCIENCE ALREADY HAVE RAISED TWO THOUSAND FIVE HUNDRED DOLLARS (\$2500.00) TOWARD THE FAITH AND REASON SYMPOSIUM EXPENSES, AND

PARAGRAPH 4: WHEREAS, A BUDGET SHORTFALL OF SEVEN HUNDRED FORTY-FIVE DOLLARS (\$745.00) REMAINS.

PARAGRAPH 5: THEREFORE, THE LSU A&M STUDENT SENATE APPROPRIATES SEVEN HUNDRED FORTY-FIVE DOLLARS (\$745.00) TO THE POLITICAL SCIENCE GRADUATE ASSOCIATION TO DEFRAY THE COSTS OF SPONSORING THE 2000 FAITH AND REASON SYMPOSIUM ON APRIL 10-11.

PARAGRAPH 6: ALL MONIES NOT USED SHALL REVERT TO THE GENERAL CONTINGENCY. THIS BILL SHALL BECOME NULL AND VOID AS OF JUNE 30, 2000.
