A BILL

TO APPROPRIATE THREE HUNDRED SIXTY DOLLARS (\$360.00) TO THE GAMMA PHI GAMMA LATIN-AMERICAN SERVICE FRATERNITY TO HELP DEFRAY THE COST OF HOSTING THE CONFERENCE ON LATINO AND MULTICULTURAL AFFAIRS.

PARAGRAPH 1: WHEREAS, THE CONFERENCE ON LATINO AND MULTICULTURAL AFFAIRS IS SCHEDULED FOR APRIL 8TH, 2000, AND

PARAGRAPH 2: WHEREAS, THE LATIN-AMERICAN STUDENT POPULATION OF LOUISIANA STATE UNIVERSITY IS GROWING INTO AN INTEGRAL PART OF LOUISIANA STATE UNIVERSITY, AND

PARAGRAPH 3: WHEREAS, THE GAMMA PHI GAMMA LATIN-AMERICAN SERVICE FRATERNITY WILL BECOME BETTER PREPARED IN HELPING STUDENT RELATIONS AND AIDING THE LOUISIANA STATE UNIVERSITY COMMUNITY AS A RESULT OF ATTENDING THE STUDENT CONFERENCE, AND

PARAGRAPH 4: WHEREAS, THE CONFERENCE ON LATINO AND MULTICULTURAL AFFAIRS WILL BE SIGNIFICANT BECAUSE IT IS THE FIRST TIME GAMMA PHI GAMMA WILL HOST A CONFERENCE AND IT WILL BRING PROMINENT NATIONAL LEADERS IN LATINO AFFAIRS TO LSU, AND

PARAGRAPH 5: WHEREAS, THE MEMBERS OF GAMMA PHI GAMMA LATIN-AMERICAN SERVICE FRATERNITY WILL BENEFIT IN ATTENDING THE CONFERENCE BY LEARNING MORE ABOUT THE CHANGING ROLES OF MINORITIES IN LEADERSHIP POSITIONS.

PARAGRAPH 6: THEREFORE, BE IT RESOLVED THAT THE LSU A&M STUDENT SENATE DOES HEREBY APPROPRIATE THREE HUNDRED SIXTY DOLLARS (\$360.00) TO THE GAMMA PHI GAMMA LATIN-AMERICAN SERVICE FRATERNITY TO HELP DEFRAY THE COSTS OF HOSTING THE CONFERENCE ON LATINO AND MULTICULTURAL AFFAIRS.

PARAGRAPH 7: ALL MONIES NOT USED SHALL REVERT TO THE GENERAL CONTINGENCY. THIS BILL SHALL BECOME NULL AND VOID AS OF JUNE 30, 2000.
