A BILL

TO APPROPRIATE ONE THOUSAND, NINE HUNDRED SEVENTY-FIVE DOLLARS (\$1975.00) TO THE LOUISIANA STATE UNIVERSITY INTERFRATERNITY COUNCIL (IFC) TO HELP DEFRAY THE COSTS OF ATTENDING THE UNDERGRADUATE INTERFRATERNITY INSTITUTE (UIFI) LEADERSHIP CONFERENCE.

PARAGRAPH 1: WHEREAS, THE INTERFRATERNITY COUNCIL HAS BEEN AN INTEGRAL BODY OF LSU FOR OVER SEVENTY-FIVE (75) YEARS, AND

PARAGRAPH 2: WHEREAS, THE PRIMARY PURPOSES OF IFC ARE TO PROMOTE EFFECTIVE LEADERSHIP AMONG FRATERNITY CHAPTER MEMBERS AND TO STIMULATE INTEREST IN UNIVERSITY PROGRAMS, AND

PARAGRAPH 3: WHEREAS, THE UIFI CONFERENCE IS AN AVENUE BY WHICH IFC MEMBERS WILL GAIN VALUABLE LEADERSHIP EXPERIENCE, AND

PARAGRAPH 4: WHEREAS, MEMBERS WILL BE ABLE TO USE THEIR CONFERENCE EXPERIENCE FOR THE BETTERMENT OF THE LSU COMMUNITY.

PARAGRAPH 5: THEREFORE, THE LSU A&M STUDENT SENATE HEREBY APPROPRIATES ONE THOUSAND, NINE HUNDRED SEVENTY-FIVE DOLLARS (\$1975.00) TO THE LOUISIANA STATE UNIVERSITY INTERFRATERNITY COUNCIL TO HELP DEFRAY THE COSTS OF ATTENDING THE UNDERGRADUATE INTERFRATERNITY INSTITUTE (UIFI) LEADERSHIP CONFERENCE.

PARAGRAPH 6: ALL MONIES NOT USED SHALL REVERT TO THE GENERAL CONTINGENCY. THIS BILL SHALL BECOME NULL AND VOID AS OF JUNE 30, 2000.
