A BILL

TO APPROPRIATE ONE THOUSAND, SEVEN HUNDRED FORTY DOLLARS (\$1740.00) TO THE LSU A&M MODEL UNITED NATIONS TEAM TO ASSIST IN THE PAYMENT OF HOTEL REGISTRATION AT THE NATIONAL MODEL UNITED NATIONS CONFERENCE.

PARAGRAPH 1: WHEREAS, THE LSU A&M MODEL UNITED NATIONS TEAM BECAME A RECOGNIZED STUDENT ORGANIZATION DURING THE FALL 1998 SEMESTER, AND

PARAGRAPH 2: WHEREAS, THE COST OF TWO QUADRUPLE OCCUPANCY ROOMS FOR SIX NIGHTS IS ONE THOUSAND, SEVEN HUNDRED FORTY DOLLARS (\$1740.00), AND

PARAGRAPH 3: WHEREAS, THE HOTEL IS GIVING SPECIAL DISCOUNT RATES ON HOTEL ROOMS FOR PEOPLE ATTENDING THE CONFERENCE, AND

PARAGRAPH 4: WHEREAS, THE MODEL UNITED NATIONS TEAM APPLIED TO THE ORGANIZATION RELIEF FUND (ORF) FOR ASSISTANCE AND WILL BE RECEIVE A GRANT OF ONE THOUSAND, TWO HUNDRED DOLLARS (\$1200), AND

PARAGRAPH 5: WHEREAS, THE MODEL UNITED NATIONS TEAM HAS COLLECTED DUES FROM ITS MEMBERS AND HAS BEEN WORKING ON GETTING SPONSORSHIP MONEY FROM VARIOUS COMPANIES AND FOUNDATIONS, AND

PARAGRAPH 6: WHEREAS, THE LSU A&M MODEL UNITED NATIONS TEAM WAS INVITED TO THE NATIONAL MODEL UNITED NATIONS CONFERENCE, AN AFFILIATE OF THE ACTUAL UNITED NATIONS, AND

PARAGRAPH 7: WHEREAS, THE ATTENDANCE AT THIS CONFERENCE IS NOT ONLY AN EDUCATIONAL EXPERIENCE, BUT IT WILL ALSO BRING RECOGNITION AND PRESTIGE TO LOUISIANA STATE UNIVERSITY.

PARAGRAPH 8: THEREFORE, THE LSU A&M STUDENT SENATE APPROPRIATES ONE THOUSAND, SEVEN HUNDRED FORTY DOLLARS (\$1740.00) TO THE LSU A&M MODEL UNITED NATIONS TEAM TO HELP PAY FOR THEIR HOTEL ROOMS AT THE NATIONAL MODEL UNITED NATIONS CONFERENCE.

PARAGRAPH 9: ALL MONIES NOT USED SHALL REVERT BACK TO THE GENERAL CONTINGENCY. THIS BILL SHALL BECOME NULL AND VOID AS OF JUNE 30, 1999.
