A BILL

TO APPROPRIATE ONE THOUSAND SIX HUNDRED SIXTY DOLLARS AND ELEVEN CENTS (\$1,660.11) TO THE LSU DEPARTMENT OF LANDSCAPING SERVICES TO DEFRAY THE COST OF THE CONSTRUCTION OF A SIDEWALK ALONG SOUTH STADIUM DRIVE EXTENDING TO HIGHLAND ROAD FROM THE EXISTING SIDEWALK LINKING BLAKE HALL'S PARKING LOT TO SOUTH STADIUM DRIVE.

- PARAGRAPH 1:** WHEREAS, TREE ROOTS ARE CURRENTLY EXPOSED ALONG THE SOUTH STADIUM WALKWAY AND THERE HAVE BEEN REPORTED INCIDENTS OF STUDENTS WHO HAVE STUMBLER OVER THE EXPOSED TREE ROOTS AS THEY WALK FROM THE PARKING AREA ALONG SOUTH STADIUM ROAD TO HIGHLAND ROAD, AND
- PARAGRAPH 2:** WHEREAS, THIS WALKWAY IS A HIGH TRAFFIC AREA FOR STUDENTS WHO WALK FROM THE SOUTH STADIUM ROAD PARKING AREA AND THE STUDENT RECREATIONAL COMPLEX TO GET TOWARDS HIGHLAND ROAD, AND
- PARAGRAPH 3:** WHEREAS, THERE IS CURRENTLY A SIDEWALK THAT LINKS BLAKE HALL'S PARKING LOT TO SOUTH STADIUM DRIVE AND THIS PROPOSED SIDEWALK WOULD EXTEND THE EXISTING SIDEWALK ALONG SOUTH STADIUM DRIVE TO HIGHLAND ROAD, AND
- PARAGRAPH 4:** WHEREAS, THE CONSTRUCTION OF THIS SIDEWALK WOULD ELIMINATE INCIDENTS OF STUDENTS STUMBLING OVER TREE ROOTS ALONG THIS WALKWAY AS WELL AS PROTECT AND PROLONG THE LIFE OF THE LIVE OAK TREES BY REDUCING PEDESTRIAN IMPACT ON THE ROOTS, AND
- PARAGRAPH 5:** WHEREAS, THE ONE THOUSAND SIX HUNDRED SIXTY DOLLARS AND ELEVEN CENTS (\$1,660.11) APPROPRIATION FROM THE STUDENT SENATE TO THE LSU DEPARTMENT OF LANDSCAPING SERVICES WOULD COVER MATERIAL COSTS ONLY.
- PARAGRAPH 6:** THEREFORE, BE IT RESOLVED THAT THE STUDENT SENATE HEREBY APPROPRIATES ONE THOUSAND SIX HUNDRED SIXTY DOLLARS AND ELEVEN CENTS (\$1,660.11) TO THE LSU DEPARTMENT OF LANDSCAPING SERVICES FOR THE CONSTRUCTION OF THIS PROPOSED SIDEWALK.

PARAGRAPH 7: ALL MONIES NOT USED SHALL REVERT TO THE GENERAL CONTINGENCY. THIS BILL SHALL BECOME NULL AND VOID AS OF JUNE 30, 1999.
