A RESOLUTION

**TO ESTABLISH THE ELECTION DOCUMENT REVIEW COMMITTEE (EDRC) AS A
TEMPORARY COMMITTEE OF LSU STUDENT GOVERNMENT**

- PARAGRAPH 1:** WHEREAS, LSU STUDENT GOVERNMENT IS CHARGED WITH REVISING AND AMENDING GOVERNING DOCUMENTS TO ACCURATELY REFLECT OUR MISSION; AND
- PARAGRAPH 2:** WHEREAS, THE PURPOSE OF THIS COMMITTEE WILL BE TO REVIEW THE ELECTION CODE AND ALL OTHER RELEVANT PORTIONS OF THE GOVERNING DOCUMENTS; AND
- PARAGRAPH 3:** WHEREAS, THIS COMMITTEE WILL MAKE CHANGES TO THE NECESSARY DOCUMENTS IN ORDER TO UPDATE THE LANGUAGE AND PROCESSES RELATED TO ELECTIONS; AND
- PARAGRAPH 4:** WHEREAS, THIS COMMITTEE WILL BE MADE UP OF TEN (10) VOTING MEMBERS AND FIVE (5) EX-OFFICIO, NON-VOTING MEMBERS AS FOLLOWS:

PARAGRAPH 5: WHEREAS, THIS COMMITTEE WILL MEET WEEKLY UNTIL THE END OF THE 48TH FALL REGULAR SESSION AND WILL REPORT WEEKLY TO THE STUDENT SENATE; AND

PARAGRAPH 6: WHEREAS, THIS COMMITTEE SHALL BE REINSTATED IN FUTURO AT THE INITIATIVE OF THE STUDENT SENATE OR STUDENT BODY PRESIDENT THROUGH THE PROPER LEGISLATIVE INSTRUMENTS IF DESIRED; AND

PARAGRAPH 7: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE ELECTION DOCUMENT REVIEW COMMITTEE (EDRC) BE ESTABLISHED AS A TEMPORARY COMMITTEE OF THE LSU STUDENT GOVERNMENT, AND

PARAGRAPH 8: BE IT FURTHER RESOLVED THAT THE ELECTION DOCUMENT REVIEW COMMITTEE HAVE THE POWER TO ACT AND HEAR LEGISLATION AT THE DISCRETION OF THE SPEAKER OF THE STUDENT SENATE, AND

PARAGRAPH 9: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO DR. KURT KEPPLER, VICE PRESIDENT OF STUDENT AFFAIRS; DR. MARI FUENTES-MARTIN, ASSOCIATE VICE PRESIDENT & DEAN OF STUDENTS; AND STEWART LOCKETT, STUDENT BODY PRESIDENT, AND

PARAGRAPH 10: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
