A RESOLUTION

TO RE-ESTABLISH THE STUDENT FEE VALUE ASSESSMENT COMMITTEE (SFVAC) AS A TEMPORARY COMMITTEE OF LSU STUDENT GOVERNMENT

- PARAGRAPH 1:** WHEREAS, LSU STUDENT GOVERNMENT IS CHARGED WITH ENSURING ALL STUDENT FEES ARE JUDICIOUSLY AND EFFECTIVELY EXPENDED FOR THE BENEFIT OF THE STUDENTS; AND
- PARAGRAPH 2:** WHEREAS, IT IS ALSO INCUMBENT UPON LSU STUDENT GOVERNMENT TO ADVOCATE FOR THE REMOVAL OR DECREASE OF FEES THAT DO NOT JUSTIFY THEIR FINANCIAL COST TO THE LSU STUDENT BODY; AND
- PARAGRAPH 3:** WHEREAS, THE PURPOSE OF THIS COMMITTEE WILL BE TO REVIEW STUDENT REQUIRED FEES AND THEIR OUTCOMES BY WEIGHING THE VALUE OF EACH PROGRAM, SERVICE, AND ENTITY; AND
- PARAGRAPH 4:** WHEREAS, THIS COMMITTEE WILL MAKE RECOMMENDATIONS TO THE UNIVERSITY'S EXECUTIVE ADMINISTRATION ON BEHALF OF THE STUDENT BODY TO IMPROVE VALUE AND REDUCE SPECIFIC STUDENT FEES THAT ARE DEEMED INEFFICIENT; AND
- PARAGRAPH 5:** WHEREAS, THIS COMMITTEE WILL BE MADE UP OF TEN (10) VOTING MEMBERS AND FIVE (5) EX-OFFICIO, NON-VOTING MEMBERS AS FOLLOWS:

PARAGRAPH 6: WHEREAS, THIS COMMITTEE WILL MEET BI-WEEKLY UNTIL THE END OF THE 48TH FALL REGULAR SESSION AND WILL REPORT WEEKLY TO THE STUDENT SENATE; AND

PARAGRAPH 7: WHEREAS, THIS COMMITTEE SHALL BE REINSTATED IN FUTURO AT THE INITIATIVE OF THE STUDENT SENATE OR STUDENT BODY PRESIDENT THROUGH THE PROPER LEGISLATIVE INSTRUMENTS IF DESIRED; AND

PARAGRAPH 8: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE STUDENT FEE VALUE ASSESSMENT COMMITTEE BE ESTABLISHED AS A TEMPORARY COMMITTEE OF THE LSU STUDENT GOVERNMENT, AND

PARAGRAPH 9: BE IT FURTHER RESOLVED THAT THE STUDENT FEE VALUE ASSESSMENT COMMITTEE HAVE THE POWER TO ACT AND HEAR LEGISLATION AT THE DISCRETION OF THE SPEAKER OF THE STUDENT SENATE, AND

PARAGRAPH 10: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO DR. KURT KEPPLER, VICE PRESIDENT OF STUDENT AFFAIRS; DR. MARI FUENTES-MARTIN, ASSOCIATE VICE PRESIDENT & DEAN OF STUDENTS; DAN LAYZELL, VICE PRESIDENT FOR FINANCE & ADMINISTRATION/CFO; F. KING ALEXANDER, PRESIDENT OF LSU; THE BOARD OF SUPERVISORS OF LSU; AND STEWART LOCKETT, STUDENT BODY PRESIDENT, AND

PARAGRAPH 11: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
