**A BILL**

TO APPROPRIATE TWO THOUSAND FIVE HUNDRED DOLLARS (\$2500) TO THE LSU AMBASSADORS TO HELP DEFRAY THE COSTS OF THE YELLOW LSU AMBASSADOR POLO SHIRTS AND THE REGISTRATION COSTS OF THE SOUTHERN REGIONAL ORIENTATION WORKSHOP (SROW).

- PARAGRAPH 1:** WHEREAS, THE LSU AMBASSADORS ARE THE OFFICIAL HOSTS OF CAMPUS, REPRESENTING THE LSU STUDENT BODY BOTH ON AND OFF CAMPUS, AND
- PARAGRAPH 2:** WHEREAS, THE LSU AMBASSADORS ARE A GROUP OF OVER 200 STUDENT VOLUNTEERS WHO PERFORM PEER ADVISING, RECRUITING, AND ORIENTATION FUNCTIONS, INCLUDING SPRING TESTING, FRESHMAN ADVISING, ORIENTATION AND PRE-REGISTRATION, TIGER DAY, TIGER CALLS AND SEMESTER ORIENTATION PROGRAMS, AND
- PARAGRAPH 3:** WHEREAS, THE LSU AMBASSADORS INCUR A LARGE AMOUNT OF COSTS THROUGHOUT THE YEAR THAT ARE PASSED ON TO ITS MEMBERSHIP BECAUSE OF VARIOUS EXPENSES, INCLUDING THE YELLOW POLO SHIRTS AND THE COST OF THE ANNUAL SROW CONFERENCE, AND
- PARAGRAPH 4:** WHEREAS, THE LSU AMBASSADORS ARE ONE OF ONLY A HANDFUL OF THE HUNDREDS OF COLLEGIATE ORIENTATION GROUPS WHO ARE NOT PAID FOR THEIR DUTIES, BUT ACTUALLY PAY TO DO THEIR DUTIES, AND
- PARAGRAPH 5:** WHEREAS, OTHER FUNDING OPPORTUNITIES TO DEFRAY THESE COSTS HAVE BEEN EXHAUSTED, AND ANY REMAINING COSTS ASSOCIATED WITH THE SHIRTS AND SROW WILL BE PASSED ON TO THE INDIVIDUAL MEMBERS OF THE LSU AMBASSADORS.
- PARAGRAPH 6:** THEREFORE, TWO THOUSAND FIVE HUNDRED DOLLARS (\$2500.00) IS HEREBY APPROPRIATED FROM THE GENERAL CONTINGENCY TO HELP DEFRAY THE COSTS OF THE YELLOW POLO SHIRTS AND SROW.
- PARAGRAPH 7:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY VOTE OF THE LSU A&M STUDENT SENATE. THIS BILL SHALL BECOME NULL AND VOID AS OF JUNE 30, 1998.
