A RESOLUTION

TO RECOMMEND TO THE OFFICE OF ACADEMIC AFFAIRS TO HOLD SPRING TESTING AT A TIME IN ADVANCE OF REGISTRATION FOR ENROLLED STUDENTS, IN ORDER TO PROVIDE ADEQUATE COUNSELING FOR BOTH.

PARAGRAPH 1: WHEREAS, SPRING TESTING IS HELD DURING FALL AND SUMMER CLASS REGISTRATION FOR ENROLLED STUDENTS, AND

PARAGRAPH 2: WHEREAS, CURRENT STUDENTS NEED TO BE ABLE TO HAVE THEIR SCHEDULING QUESTIONS ANSWERED AT TIMES OF REGISTRATION IN ORDER TO ENSURE THEY SCHEDULE THE PROPER CLASSES TOWARDS THEIR DEGREE, AND

PARAGRAPH 3: WHEREAS, MISTAKES IN SCHEDULING CAN LEAD TO A PROLONGED GRADUATION, AND

PARAGRAPH 4: WHEREAS, THE LSU A&M STUDENT SENATE RECOGNIZES THE NEED FOR COUNSELORS FOR SPRING TESTERS, BUT RECOMMENDS THE TIME OF SPRING TESTING BE CHANGED IN ORDER TO PROVIDE COUNSELORS FOR ENROLLED STUDENTS DURING THEIR REGISTRATION SESSIONS.

PARAGRAPH 5: THEREFORE BE IT RESOLVED THAT THE LSU A&M STUDENT SENATE HEREBY RECOMMENDS TO THE OFFICE OF ACADEMIC AFFAIRS THAT SPRING TESTING BE HELD AT A TIME IN ADVANCE OF REGISTRATION FOR ENROLLED STUDENTS, IN ORDER TO PROVIDE ADEQUATE COUNSELING FOR BOTH.
