14 PARAGRAPH 1: WHEREAS, THE NATIONAL AMERICAN SPEECH-LANGUAGE-
15 HEARING ASSOCIATION CONFERENCE IS THE PREMIER ANNUAL
16 PROFESSIONAL EDUCATION EVENT FOR SPEECH-LANGUAGE
17 PATHOLOGISTS, AUDIOLOGISTS, AND SPEECH, LANGUAGE, AND
18 HEARING SCIENTISTS; AND

20 PARAGRAPH 2: WHEREAS, BRINGING TOGETHER APPROXIMATELY 15,000
21 ATTENDEES, THE ANNUAL CONVENTION PROVIDES
22 UNPARALLELED OPPORTUNITIES TO HEAR THE LATEST RESEARCH
23 AND GAIN NEW SKILLS AND RESOURCES TO ADVANCE THE
