9 **A CONCURRENT RESOLUTION**

10 **POSTPONING THE REFERENDA CALLED BY SGCRs No. 14, No. 15, AND No. 16 OF**  
11 **THE SPRING 2018 REGULAR SESSION FROM THE FALL 2018 GENERAL ELECTION TO**  
12 **THE SPRING 2019 GENERAL ELECTION**

14 **PARAGRAPH 1:** WHEREAS, FOLLOWING THE WORK OF THE STUDENT FEE VALUE  
15 ASSESSMENT COMMITTEE (SFVAC) DURING THE SPRING 2018  
16 REGULAR SESSION, THE STUDENT SENATE PASSED THREE  
17 CONCURRENT RESOLUTIONS SENDING REFERENDA TO RATIFY  
18 SFVAC'S RECOMMENDATIONS ON CERTAIN STUDENT FEES  
19 (CAMPUS LIFE, STUDENT MEDIA, AND PERFORMANCE ARTS) TO  
20 THE STUDENT ELECTORATE, AND

22 **PARAGRAPH 2:** WHEREAS, DUE TO LOGISTICAL MATTERS, QUESTIONS  
23 REGARDING THE DETAILS OF THE CONCURRENT RESOLUTIONS,  
24 THE APPOINTMENT OF A COMPLETELY NEW ELECTION BOARD,  
25 AND CORRESPONDENCE WITH VARIOUS ADMINISTRATORS  
26 CONCERNED WITH SFVAC'S RECOMMENDATIONS, IT IS NO  
27 LONGER POSSIBLE TO HOLD THESE REFERENDA DURING THE FALL  
28 2018 GENERAL ELECTION WHILE MAINTAINING THE INTEGRITY  
29 OF THE VOTE, ESPECIALLY GIVEN FEE RECIPIENTS'

30 **PARAGRAPH 3:** STATUS AS OFFICIAL CANDIDATES IN SUCH REFERENDA UNDER  
31 THE ELECTION CODE, AND

33 **PARAGRAPH 4:** WHEREAS, MOVING THESE REFERENDA TO THE SPRING 2019  
34 GENERAL ELECTION WOULD PREVENT POTENTIAL UNIVERSITY  
35 COURT LITIGATION, ALLOW FOR POTENTIAL FURTHER  
36 DEVELOPMENTS IN THE COMING MONTHS, AND – SHOULD THE  
37 REFERENDA PROCEED – ALLOW THE QUESTIONS TO BE DECIDED  
38 BY THE LARGER TURNOUT OF A SPRING GENERAL ELECTION;

40 **PARAGRAPH 5:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA  
41 STATE UNIVERSITY STUDENT SENATE THAT THE  
42 REFERENDA CALLED BY SGCRs No. 14, No. 15, AND No. 16 OF  
43 THE SPRING 2018 REGULAR SESSION ARE HEREBY REMOVED  
44 FROM THE FALL 2018 GENERAL ELECTION BALLOT AND PLACED  
45 ON THE SPRING 2019 GENERAL ELECTION BALLOT; AND

47 **PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS  
48 RESOLUTION BE TRANSMITTED TO COMMISSIONER OF  
49 ELECTIONS ERICA BORNE, CHIEF JUSTICE ANDREW CHENEVERT,  
50 DIRECTOR OF CAMPUS LIFE JACOB BRUMFIELD, DIRECTOR OF  
51 STUDENT MEDIA JOHN FRISCIA, DEAN OF THE COLLEGE OF  
52 MUSIC AND DRAMATIC ARTS TODD QUEEN, DIRECTOR OF  
53 STRATEGIC COMMUNICATIONS JASON DRODDY, CHIEF  
54 FINANCIAL OFFICER DAN LAYZELL, INTERIM PROVOST HAYNIE,

**PARAGRAPH 7:**

THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
