**A BILL**

**TO AMEND THE STUDENT SENATE RULES OF ORDER TO ALLOW SENATORS TO  
SERVE AS PARLIAMENTARIAN IN THE CASE OF A VACANCY IN THE POSITION**

**BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT  
SENATE OF LOUISIANA STATE UNIVERSITY AND AGRICULTURAL  
AND MECHANICAL COLLEGE**


**PARAGRAPH 1:** RULE 2.9 (D) OF THE STUDENT SENATE RULES OF ORDER IS  
HEREBY AMENDED TO READ AS FOLLOWS:

**RULE 2.9. LEGISLATIVE STAFF TITLES, ELECTIONS, APPOINTMENTS,  
RESIGNATION AND REMOVAL**


(D) ALL OFFICERS AND STAFF HEREIN LISTED SHALL BE NON-MEMBERS OF  
THE SENATE, EXCEPT FOR THE SERGEANT-AT-ARMS, DIRECTOR OF  
COMMUNICATIONS, DIRECTOR OF DEVELOPMENT, DIRECTOR OF  
PROGRAMMING, AND PARLIAMENTARIAN.

**PARAGRAPH 2:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-  
THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND  
SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR  
PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT  
AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE  
DATE OF SUCH APPROVAL.
