A FINANCE BILL

TO ALLOCATE A MAXIMUM OF TWO THOUSAND THREE HUNDRED AND EIGHTY DOLLARS AND ELEVEN CENTS (\$2,380.11) FROM THE LEGISLATIVE INITIATIVES ACCOUNT TO FUND THE STUDENT GOVERNMENT AND GEAUX VOTE INAUGURAL LEGISLATIVE BREAKFAST.

PARAGRAPH 1: WHEREAS, IN THE PAST YEAR LSU'S COORDINATED EFFORTS HELPED TO REGISTER OVER 2,000 STUDENTS TO VOTE; AND

PARAGRAPH 2: WHEREAS, VOTING AND CIVIC ENGAGEMENT REQUIRE EDUCATION AND ACCESS TO INFORMATION ON CANDIDATES AND POLICIES; AND

PARAGRAPH 3: WHEREAS THIS BREAKFAST WOULD BE AN UNPRECEDENTED OPPORTUNITY FOR STUDENTS TO HAVE PERSONAL INTERACTION WITH LEGISLATORS AND PUBLIC SERVANTS; AND

PARAGRAPH 4: WHEREAS THE FUNDS WOULD GO TO THE FOLLOWING:

- 1. TRADITIONAL BREAKFAST: \$12.75 PER PERSON (X150)**
- 2. GRATUITY: \$286.88**
- 3. TAX (9.45%): \$180.73**
- 4. TOTAL: \$2,380.11**

PARAGRAPH 5: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT TWO THOUSAND THREE HUNDRED AND EIGHTY DOLLARS AND ELEVEN CENTS \$2,380.11 BE ALLOCATED FROM THE LEGISLATIVE INITIATIVES ACCOUNT TO FUND THE GEAUX VOTE EVENT ON APRIL 4TH, AND

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO MRS. CORTNEY GREAVIS, THE STUDENT GOVERNMENT FINANCIAL COORDINATOR AT LOUISIANA STATE UNIVERSITY

PARAGRAPH 7: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
