A FINANCE BILL

TO ALLOCATE SIX THOUSAND FIVE HUNDRED DOLLARS AND ZERO CENTS \$6,500 FROM THE LEGISLATIVE CONTINGENCY ACCOUNT TO FUND THE REGISTRATION COSTS OF THE STUDENTS ATTENDING THE 2019 SXSW CONFERENCE IN AUSTIN, TEXAS MARCH 8-12

PARAGRAPH 1: WHEREAS, THE GROUP OF STUDENTS ATTENDING THIS CONFERENCE CONSIST OF PAST, CURRENT AND FUTURE MANSHIP STUDENTS WHO HAVE GRADUATED OR ARE GRADUATING WITH A DEGREE IN MASS COMMUNICATION WITH A CONCENTRATION IN JOURNALISM, DIGITAL ADVERTISING, PUBLIC RELATIONS OR POLITICAL COMMUNICATION; AND

PARAGRAPH 2: WHEREAS, EACH OF THESE CONCENTRATIONS ARE REPRESENTED IN THE GROUP OF MANSHIP STUDENTS ATTENDING THE CONFERENCE; AND

PARAGRAPH 3: WHEREAS, THE GROUP OF STUDENTS WILL PARTAKE IN PROFESSIONAL NETWORKING OPPORTUNITIES AND SPECIFIC PANEL DISCUSSIONS, FEATURE SESSIONS AND KEYNOTE SPEECHES RELATING TO THEIR RESPECTIVE CONCENTRATION; AND

PARAGRAPH 4: WHEREAS, SXSW CONFERENCE OFFERS 25 TRACKS ATTENDEES CAN CHOSE FROM SUCH AS: MEDIA & JOURNALISM, BRANDS & MARKETING, SOCIAL & GLOBAL IMPACT, CITIES, GOVERNMENT & POLITICS, EXPERIMENTAL STORYTELLING, FILM & TV INDUSTRY AND SPORTS; AND

PARAGRAPH 5: WHEREAS, ATTENDING THE 2019 SXSW CONFERENCE WILL ALLOW THESE STUDENTS TO NETWORK WITH WHAT SXSW DESCRIBES AS ONE OF THE MOST DIVERSE, COLLABORATIVE AND INVENTIVE COMMUNITIES IN THE WORLD, AND ALLOW THEM TO EXCEL IN FUTURE PROJECTS AT LSU AND AT THEIR FUTURE WORKPLACES; AND

PARAGRAPH 6: WHEREAS, THE FUNDING WILL BE ALLOCATED AS FOLLOWS:

PARAGRAPH 7: **1. REGISTRATION (20 PEOPLE): \$6,500**

PARAGRAPH 8: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT SIX THOUSAND FIVE HUNDRED DOLLARS AND ZERO CENTS \$6,500 FROM THE LEGISLATIVE CONTINGENCY ACCOUNT TO FUND THE REGISTRATION COSTS OF THE STUDENTS ATTENDING THE 2019 SXSW CONFERENCE IN AUSTIN, TEXAS MARCH 8-12, AND

PARAGRAPH 9: BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO MANSHIP INSTRUCTOR SADIE WILKS AND STUDENT GOVERNMENT FINANCIAL COORDINATOR CORTNEY GREAVIS

PARAGRAPH 10: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
