**A Concurrent Resolution**

*To place the 2021 Constitution on the Spring 2021 Ballot*

- 1 WHEREAS, SGB 2, a bill to amend the LSU Student Government
- 2 Governing Documents, passed the LSU Student Senate; and
- 3 WHEREAS, Article IX, Section 1.B. of the Student Government
- 4 Constitution states that constitutional amendments “must further
- 5 be ratified by a majority of the students voting in any campus-wide
- 6 election of the Student Government”;
- 7 THEREFORE BE IT RESOLVED BY THE LOUISIANA STATE
- 8 UNIVERSITY STUDENT SENATE, that Student Government
- 9 submits a referendum to the electors of the University and further
- 10 authorizes the following proposition be placed on the Spring 2021
- 11 Student Government Election ballot:
- 12 “A new Student Government Constitution has been proposed. Shall this
- 13 proposed Constitution be ratified and brought into effect?
- 14 Link to SGB No. 2
- 15 Link to such explanatory resources as the Election Board may direct

18 BE IT FURTHER RESOLVED THAT the Election Board shall place  
19 or cause to be placed, for the purpose of voter education, factual  
20 information related to the subject of the referendum on the Elections  
21 page of the Student Government website and such other places as  
22 shall aid in the dissemination of such information.

24 BE IT FURTHER RESOLVED THAT A COPY OF THIS  
25 RESOLUTION BE SUBMITTED TO the Commissioner of Elections,  
26 Rehm Maham.

28 THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE by  
29 a two-thirds vote of the LSU Student Senate and signature by the  
30 Student Body President, upon lapse of time for presidential action,  
31 or if vetoed by the President and subsequently approved by the  
32 Senate, on the date of such approval.
