A Resolution

*To Urge and Request the Election Board to Select Deshaun Gaskins as
Vice Commissioner*

1 WHEREAS, The position of Vice Commissioner of Elections, as
2 defined in the Student Government Election Code, is to be appointed
3 by the President and approved by the Senate during the Spring
4 Organizational Session; and

5 WHEREAS, In the case of a vacancy, the Election Board shall elect
6 a new Vice Commissioner amongst the remaining members of the
7 Election Board; and

8 WHEREAS, Deshaun Gaskins has served as an Election Board
9 member this past semester; and

10 WHEREAS, Deshaun Gaskins has been shown to be well versed in
11 the Election Code and expressed values in establishing a fair
12 election, while increasing voter turnout; and

13 THEREFORE BE IT RESOLVED BY THE LOUISIANA STATE
14 UNIVERSITY STUDENT SENATE, that Deshaun Gaskins is to be

15 suggested to be the Vice Commissioner of Elections for the Spring
16 2021 Elections.

17 BE IT FURTHER RESOLVED THAT A COPY OF THIS
18 RESOLUTION BE SUBMITTED TO the LSU Student Government
19 Election Board.

20 THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE by
21 a simple majority (one-half plus one) vote of the LSU Student
22 Senate and signature by the Student Body President, upon lapse of
23 time for presidential action, or if vetoed by the President and
24 subsequently approved by the Senate, on the date of such approval.
