**A Resolution**

*To urge and request that Parade Ground Events be put on the Spring 2021  
Ballot.*

1 WHEREAS, as representatives elected by the Student Body, we  
2 advocate for their needs and request; and

4 WHEREAS, to appropriately stand for their values we suggest  
5 placing this initiative to hold an event on the parade grounds on the  
6 Spring 2021 Ballot to have students vote for how they would like  
7 their money spent.
