**A Finance Bill**

*To allocate a maximum of one thousand eight hundred and sixty dollars (\$1,860) from the Student Government initiatives account to purchase 6 study corrals to be installed in the union.*

*Enacted,*

- 1 WHEREAS, LSU currently has desktop computers located on the first
- 2 floor of the student union that are not used frequently; and
- 3 WHEREAS, a survey resulted in only 28% of respondents being
- 4 opposed to the removal of these computers; and
- 5 WHEREAS, that survey also resulted in numerous respondents
- 6 expressing they would like the area where these desktops currently are
- 7 to be equipped with more charging outlets and resemble more of an
- 8 individual study area; and
- 9 WHEREAS, the IT department has expressed that the age of these
- 10 computers requires maintenance costs that they believe outweigh the
- 11 benefits of keeping them in use; and
- 12 WHEREAS, auxiliary services has agreed to cover the cost of removing
- 13 the current desktops

15 WHEREAS, the funds will be allocated as follows:

16 \$1,860 for the purchase of all 6 corrals

17 THEREFORE BE IT ENACTED BY THE LOUISIANA STATE  
18 UNIVERSITY STUDENT GOVERNMENT SENATE that a maximum  
19 of one thousand eight hundred and sixty dollars (\$1,860) from the  
20 Student Government initiatives account be allocated to fund the  
21 purchase of 6 study corrals to be installed in the union; and

22 BE IT FURTHER RESOLVED that a copy of this bill be sent to the  
23 Assistant Vice President of Auxiliary Services, Margot Carroll.

24 THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-  
25 THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND  
26 SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR  
27 PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT  
28 AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE  
29 DATE OF SUCH APPROVAL.


