A Finance Bill

To Allocate One Thousand Eight Hundred and Twenty-Five Dollars and Ninety-Six Cents (\$1,825.96) from the Student Government Surplus account to fund a portion of the cost of the fabrication and installation of a sign for the Himes Testing Center

- 1 WHEREAS, installation of a sign in front of the Himes Testing Center will be
2 beneficial to helping students locate the Testing Center; and
- 3 WHEREAS, locating the Testing Center has been an issue for many students
4 in the past; and
- 5 WHEREAS, the Himes Testing Center is currently undergoing renovations
6 and that will include a new location and entrance to the Testing Center, in
7 which a sign will also be helpful for students finding this new location; and
- 8 WHEREAS, a sign will help to reduce the added stress of trying to find the
9 Testing Center on top of having to take an exam (particularly for new students
10 and those who have never utilized the Testing Center); and

11 WHEREAS, in order to fund a portion of this sign, one thousand, eight
12 hundred and twenty-five dollars and ninety-six cents (\$1,825.96) will be
13 allocated to LSU Facility Services/LSU Planning, Design, & Construction
14 Building for the fabrication and installation of this sign (which is half of the
15 actual cost of the sign, which is \$3,651.91); and

16 WHEREAS, the funds will be allocated as follows:


17 \$1,825.96 to help fund a portion of: shop drawings for approval (which
18 includes initial drawings and one revision), material samples as required, field
19 verification of measurements (if required) prior to shop drawings and
20 fabrication, complete fabrication and finishing of all signage, complete project
21 management and coordination of fabrication and installation schedules with
22 general contractor or related trades as required, crate and delivery of all signs
23 to job site, touch up/clean up, and as-builts and instructions.

24 THEREFORE IT BE ENACTED BY THE LOUISIANA STATE UNIVERSITY
25 SENATE that one thousand eight hundred and twenty-five dollars and ninety-
26 six cents (\$1,825.96) from the Student Government Surplus account be
27 allocated to help fund a portion of the cost of the fabrication and installation of
28 a sign for the Himes Testing Center; and

29 BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE
30 TRANSMITTED TO Sandi Guillot, Operations Manager for the Center for
31 Academic Success; David O'Brien, Director of the Himes Testing Center;
32 Frank Sipos, Coordinator of the Himes Testing Center; Danielle Welborn, of
33 LSU Planning, Design, & Construction Building; Gregory Lacour, Director of
34 Campus Planning; Dennis Mitchell, Assistant Director of Facility Services;
35 and Cortney Greavis, Student Government Program Manager

36 THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2)
37 VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE
38 PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF
39 VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE
40 SENATE, ON THE DATE OF SUCH APPROVAL.
