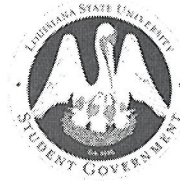

- 8 WHEREAS, the presence of a slogan from a rival school on our campus is a
- 9 mockery to our student body and our hard-working student athletes; and

- 11 THEREFORE BE IT RESOLVED BY THE LOUISIANA STATE
- 12 UNIVERSITY STUDENT SENATE, that Student Government urges and
- 13 requests that Louisiana State University remove the trademarked rally cry,
- 14 "Roll Tide", from the sidewalk outside of Taylor Hall.

- 16 BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE
- 17 SUBMITTED TO Tammy Millican, Executive Director of Facility Services
- 18 and the University of Alabama Student Government Senate.

21 majority (one-half plus one) vote of the LSU Student Senate and signature by
22 the Student Body President, upon lapse of time for presidential action, or if
23 vetoed by the President and subsequently approved by the Senate, on the
24 date of such approval.
