*To Urge and Request LSU to lower the Dean's list requirements
from 15 credit hours to 12 credit hours*

- 1 WHEREAS, only 12 hours are required to be a full time student; and
- 2 WHEREAS, 11 of the 14 schools in the SEC require 12 hours to
- 3 achieve Dean's list; and

- 5 WHEREAS, the GPA requirement will remain the same; and

- 7 WHEREAS, freshman are likely to drop classes which could put the
- 8 below the threshold; and

- 10 WHEREAS, certain major specific paths and seniors do not always
- 11 need to be taking 15 hours; and
- 12
- 13 WHEREAS, achieving a 3.5 GPA with 12 hours is still an adequate
- 14 representation of the challenges associated with Dean's List status;

- 17 WHEREAS, Students receiving a 4.0+ GPA while taking over 12 and
- 18 under 15 hours will still achieve Dean's

- 22 requests that LSU reconsiders the requirements for Dean's List to


